

TERMS & CONDITIONS OF ENTRY ELA 2016

1. DEFINITIONS

1.1. In these Terms, the following definitions apply:

1.1.1 'Terms' mean these terms and conditions of entry to the Exhibition and any terms set out within the Registration Process, as the same may be amended, modified or supplemented from time to time in accordance with these provisions.

1.1.2 'Registration Process' means the registration form to which these Terms are appended or the details provided as part of the online registration process by which Delegates are registered for entry to the Exhibition in return for the Delegate Fee.

1.1.3 'Delegate' means the person or persons named within the Registration Process for entry as a delegate or delegates to the Exhibition.

1.1.4 'Organiser' and 'LATA' means Latin American Travel Association, of 20 Upper Tachbrook Street, London SW1V 1SH.

1.1.5 'Exhibition' means the exhibition organised by LATA and known as Experience Latin America Exhibition 2016 as detailed within the Registration Process.

1.1.6 'Exhibition Venue' means the location for the Exhibition as notified by the Organiser.

1.1.7 'Owner' means the owners and management of the appointed Exhibition Venue, its employees or agents.

1.1.8 'Delegate Fee' means the delegate fee payable by or on behalf of each Delegate as detailed within the Registration Process. All fees are set in British Pounds.

1.1.9 'Force Majeure' will mean any circumstance beyond the reasonable control of the Organiser and/or the Owner including but not limited to any acts of god, epidemics, pandemics, swine flu, fires, explosions, earthquakes, floods, volcanic eruptions, ash clouds, storms, tempest, lightning, strikes or lockouts, riots, civil commotions & disturbance, war, rebellion or harmful acts for political, terrorist, biochemical attacks, cyber-attacks, national mourning or other similar purposes, material emergency, terrorist or military activity, labour disputes, accident, interventions and regulations.

1.2 The heading in these Terms are for convenience only and they must not be construed as limiting or defining the content of any clause.

1.3 A Delegate's right to attend the Exhibition shall only come into existence when the Delegate's registration is confirmed as accepted in writing by the Organiser.

2. TERMS OF THE CONTRACT

2.1 These Terms (including any incorporated as part of the Registration Process) constitute the entire agreement between the Delegate and the Organiser. All other terms, expressed or implied by statute or otherwise, are excluded to the fullest extent permitted by law.

2.2 These Terms will be governed by and construed according to English law. Any disputes between the parties in respect of the Exhibition will be subject to the exclusive jurisdiction of the English courts.

3. FEES AND PAYMENT

3.1 Full payment of the Delegate Fee is due within 10 days of each Delegate's registration being confirmed by the Organiser as accepted.

3.2 Delegate Fees are payable by bank transfer or Paypal and are subject to VAT at the prevailing rate (if applicable).

4. TICKETS AND PASSES

4.1 The Organiser will issue official entry badges and no other form of admission ticket will be valid.

4.2 Entry badges will be emailed to Delegates prior to the event.

4.3 No Delegate will be admitted to the Exhibition without presenting a valid entry badge at the entrance.

4.4 Entry badges are valid only for the named Delegate and are not transferable without the prior consent of the Organiser.

4.5 The Organiser reserves the right to issue complimentary entry badges at its sole discretion.

5. DELEGATE BEHAVIOUR AND RIGHT TO EJECT

5.1 Delegates must comply at all times with all instructions and requirements of the Organiser and the Owner and anyone else in authority in respect of the Exhibition and the Exhibition Venue.

5.2 Smoking is prohibited throughout the Exhibition Venue save in any external area that is specifically designated as a smoking area by the Owner.

5.3 Delegates are not permitted to take part in any canvassing or leafleting or other promotional activities nor conduct or organise any petitioning or demonstration nor act in any way that may reasonably be considered objectionable or which is likely to disrupt the Exhibition in any way. The Organiser reserves the right, at its absolute discretion, to withdraw a pass issued to any Delegate or eject any person or persons from the Exhibition where there is any breach of these Terms.

6. ORGANISER'S RIGHT TO TERMINATE AND AMEND

6.1 The Organiser reserves the right at its sole discretion to abandon, cancel or suspend the Exhibition, in whole or part, if it considers that delegate or exhibitor participation or support is not sufficient to make the Exhibition economically viable. The Organiser's decision will be final.

6.2 In the event of the abandonment, cancellation or suspension of the Exhibition as detailed in 6.1, Delegates will be entitled to receive repayment of any Delegate Fee paid. However, the Organiser will not be liable to any Delegate in respect of any actions, claims, losses (including consequential losses), costs or expenses which the Delegate may have incurred as a result of the abandonment, cancellation or suspension of the Exhibition.

6.3 The Organiser reserves the right to amend these Terms at any time in the interest of the good management of the Exhibition, at its absolute discretion.

7. PHOTOGRAPHY

7.1 Logos, stands, branding and other promotional outlets must not be photographed, drawn, copied or reproduced without the written permission of the Organiser.

7.2 The Organiser reserves the right to take photographs, films and videos or other recordings of the Exhibition for the purposes of promoting the Exhibition in future years.

8. FORCE MAJEURE

If the Exhibition is abandoned, cancelled or suspended, in whole or in part, by reason of Force Majeure, the non-availability of the Exhibition Venue or any other causes outside of the reasonable control of the Organiser, the Organiser's liability towards each Delegate shall be limited to the repayment of any Delegate Fee paid (or a proportionate part thereof depending on the period of any abandonment, cancellation or suspension) and under no circumstances shall the Organiser be liable in respect of any other actions, claims, losses (including consequential losses), costs or expenses whatsoever which the Delegate may have incurred as a result.
